- I. Call to Order:** The meeting was called to order at 11:00 A.M. by Mr. Sheridan.
- II. Introductions:** General Assembly conducted self-introductions.
- III. Approval of April 21, 2020 Minutes:** Ms. Burkhardt pointed out that CHI St. Joseph Madison was present at the last meeting but marked absent. Mr. Deramus motioned to approve the April 21, 2020 minutes with the change. Ms. Parks seconded; motion carried.

- IV. Financial Report:** Mr. Sheridan provided the financial report as summarized on page 5-20 of the BVRAC General Assembly packet. The current balance remaining in the Systems Development Operational budget for the committees is approximately \$16,500. Travel claims that were pending have been paid and there is a pending expense of \$3,250 towards PPE purchases that will come out of that total.

The \$6,435.48 expense in the unrestricted account is payment to Washington County for BVWACS radios. One agency has reimbursed the RAC for the expense and when the other two agencies pay their invoices, this expense will be fully reimbursed. BVRAC also paid \$750 towards stickers for ID cards of essential personnel.

There is one provider that needs to submit reimbursement paperwork for the current EMS County allocation. Once this request is processed, the next contract will be opened and is available for expenses from May 1, 2020.

Mr. Deramus made a motion to accept the financial report as presented. Mr. Leland seconded; motion carried.

V. Discussion and/or Action Items

- A. Consider for approval EMS LPG Plan** – There is \$12,500 available in the LPG Grant that is geared towards EMS providers for training, equipment, supplies and other needs. At the last Board meeting, members presented the Aeroclave RDS 3110 decontamination unit as an option to support the region's response to COVID-19. Mr. Deramus said that a comparison was done between several different units and that unit came out as the best option from a reliable company. The proposal is to buy three units utilizing funds from several sources to have a unit in the northern, central and southern areas of the region. Each unit costs approximately \$14,000 with additional cost for the solution. Several EMS Providers have been contacted about this project and policies will be developed for maintenance and availability of the units for the agency that assumes responsibility of one. Mr. Deramus made a motion to approve the LPG Plan to spend \$12,500 towards Aeroclave RDS 3110 units. Mr. Matthews seconded; motion carried.
- B. Consider for approval SB500 Allocation Plan** – There is \$27,500 available in the SB500 grant that was originally for the arm band project or stop the bleed kits. The state sent out a message stating that the funds can be used to support COVID-19 response in the region. The Board recommends that the funds be used to support the LPG/Decontamination unit project and be used to purchase two additional units. Mr. Deramus made a motion to use the SB500 Allocation to purchase two Aeroclave RDS 3110 Units. Ms. Parks seconded; motion carried.

- C. **Consider for approval FY20 EMS RAC & System Development Operational Budget** – The funds were originally allocated to purchase PPE but due to supply issues with some items and the fact that most agencies are in sustainment operations, the recommendation is to use these funds to support the purchase of the decontamination units and solution. Mr. Matthews made a motion to use the remaining funds to support the purchase of the decontamination units and solution. Mr. Leland seconded; motion carried.

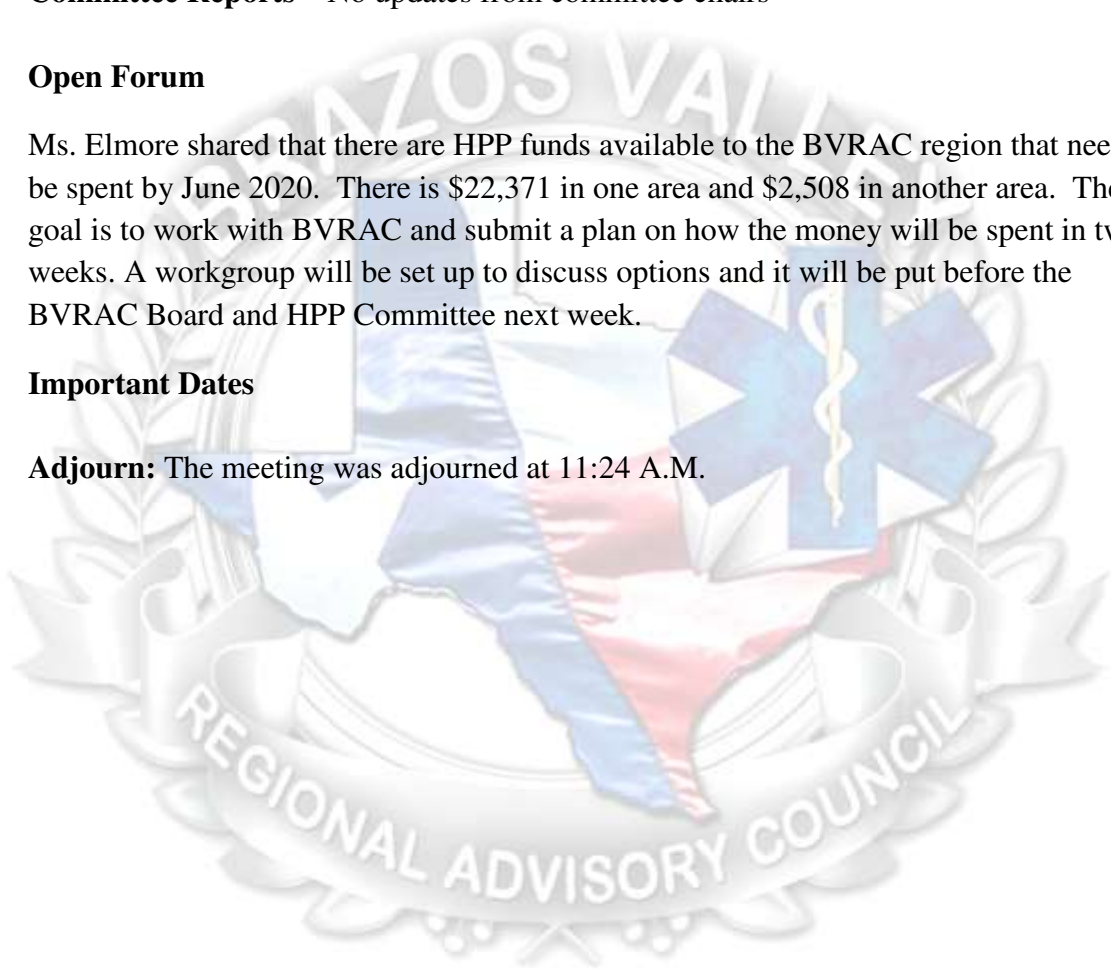
