- I. Call to Order The meeting was called to order at 10:00 A.M. by Mr. Sheridan.
- **II. Introductions** All members introduced themselves.
- III. Approval of August 6, 2020 Meeting Minutes –Ms. Parks motioned to approve the August 6, 2020 meeting minutes. Mr. Ruemke seconded; motion carried.
- **IV. Financial Report** − Mr. Sheridan directed the board's attention to pages 5 − 22 of the packet to review the financial report. There will be a zero balance for all contracts by the end of the month. As a reminder, funds were reallocated from the management side to purchase decon units which left a balance of \$13,478 in the SB 500 funds. The board needs to decide today how those funds need to be used.

Mr. Sheridan displayed the new format for the financial report that will be used for the next fiscal year. The supporting documents will still be included as well.

Mr. Matthews motioned to approve the financial report as presented. Ms. Johse seconded; motion carried.

### V. Executive Directors Report

- **A. EMS County Update** EMS County updated was covered during the financial report.
- **B. SB 500 New Project Discussion** SB 500 was originally a wristband project but was changed to purchase decon units to support the region's COVID-19 response. The SB 500 funds were saved by using unexpended management funds. There has been some discussion on purchasing additional decon units. Each unit is about \$16,000 and includes 5-6 gallons of the solution.
- **C. BVRAC Senior Christmas Sponsorship** In the past, hospitals have gathered comfort items to support the BVCOG Senior Christmas. The proposal for this year is for BVRAC to provide monetary support for care items for nursing home staff that are overworked and understaffed.
- D. Committee Budget Discussion There have been several discussions to use some money from the committee budgets to support purchase of additional decon units. Ms. Kopech shared that with the current situation it is hard to schedule in person training. Mr. Matthews suggested that any units purchased go out to the outlying counties since there are at least two in Brazos County. Mr. Sheridan asked if there is any need for stop the bleed training kits in the region. Ms. Parks would like to have a small one in Washington County. The board also discussed having some funds set aside for conference expenses whether they are in person or virtual. Mr. Rice thinks that there should be some funds set aside for EMS training. The board recommended that \$10,000 be set aside for EMS training and that a small Stop the Bleed training kit be purchased. The remaining funds should support purchase of decon units and solution.

#### VI. Action Items

- **A.** Consider for approval Senior Christmas Sponsorship for providing LTCF Healthcare workers appreciation gifts Dr. Ohaju made a motion to provide \$1,000 towards appreciation gifts for nursing home staff. Ms. Johse seconded; motion carried.
- **B.** Consider for approval modifications to meeting schedule Mr. Sheridan asked if there needed to be any changes to the current schedule of meetings. Board members present agreed to keep the current schedule as is.

## VII. Committee Reports

**A. Education (Ashley Kopech):** Ms. Kopech shared that the group still needs opportunities to learn. The case studies / instruction presentations during General Assembly will start again in October with Baylor Scott and White offering a training

Hurricane Laura - Mr. Sheridan shared that there are still a significant number of evacuees that are housed in the Dallas area. There is one nursing home that was evacuated to Washington County. They hope to be able to go back home next week but they need to get clearance from the fire department and city to go back.

Mr. Sheridan asked if there is any information the board needs during a major event. Mr. Rice said that EMS agencies need more visibility/information when nursing homes need to be evacuated. They were getting emergency calls to come unload people from buses right now. Mr. Matthews commented that the information was getting to them but the timing was not right.
