- I. **Call to Order** – The meeting was called to order at 10:00 A.M. by Chairman Rice.
- II. **Introductions** – All members introduced themselves.
- III. **Approval of August 5, 2021 Meeting Minutes** – Members present reviewed the minutes. Mr. Matthews motioned to approve the August 5, 2021 meeting minutes. Ms. Kopech seconded; motion carried.
- IV. **Financial Report** – Ms. Spittler directed the board’s attention to page 5 of the board packet for the roll up for each of the programs to see where we are at. These financials are through 7/31 so they are a little dated and purchases have been made since then. In RAC Systems Development there is \$6,550.73 remaining, in EMS RAC there is \$18,497.27 remaining and

in EMS LPG there is \$11,282 remaining. Pages 8-13 are the actual financials that show how the money was spent and how the revenue comes in. The check register and revenue ledger show an itemized list of checks and revenues for BVRAC.

Mr. Ruemke motioned to approve the financial report as presented. Mr. Matthews seconded; motion carried.

V. Executive Directors Report

- A. Project Purchase Report** – Mr. Kazmir displayed a spreadsheet showing the current status on approved purchases to close out the contract. We are waiting on the final shipment for the tourniquets, stop the bleed kits and training kits. All funds have been expended.

VI. Discussion and/or Action Items

- A. Call for nomination of a new Hospital & Acute Care Committee Chair** – Ms. Kopech noted that this position has a lot of responsibility with it. The group agreed to promote it and bring it back next meeting for approval so it can be put before the General Assembly.
- B. Discuss goals and objectives for FY2022** – Board members were provided with a copy of last year's goals and objectives. Mr. Kazmir reminded the members that if the board is going to be successful this year in hitting our targets, the targets must be defined. The committee chairs need to review their portion of last year's objectives and make updates and add to the objectives.

VII. Committee Reports

- A. Education (Ashley Kopech for Jason Giles):** Notifications have been sent out on the BLS/Stop the Bleed course. Information needs to be shared because there have not been a lot of bites. Intended audience is more towards the community. The ACLS courses will be geared more towards the medical community.
- B. Pre-Hospital (Kevin Deramus):** No updates
- C. Hospital Care and Management/ Acute Care (Deborah Burkhardt):** No updates. Group present agreed that the symposium should be planned for the spring and if it must be held virtually it can be.
- D. Stroke (Paula Terrell):** The Stroke System Plan has been started and need input and feedback on what has been developed.

Board members discussed the need for local dispatch systems to be able to know when the local doctor's call schedule and that interventional stroke is available and be able to guide crews on where a stroke patient should go for immediate intervention care. Schedules are available in EMResource but dispatch centers are

busy and chaotic. Lots of little pieces need to come together and connect to improve the system.

The question came up on what is the percentage of Large Vessel Occlusions (LVOs) that need intervention. The numbers are low across the region on this. Suggestion was made to run a report for the region and include it in our plans/report.

E. System QI/Physician’s Advisory (Dr. Ohaju): No report

F. Injury Prevention (Ashley Johse): Report covered in Education.

G. Disaster/Emergency Preparedness Committee (Cory Matthews/Rayse Richards): Need to develop plans on how to utilize the wristbands. The main idea of the project is when EMS picks up a patient, the patient gets a band and has his/her own unique number that follows them through the system. The challenge is for the hospitals on where the number goes in the care record. Need to utilize what has already been done and start doing it now so it will be used during emergencies.

H. Perinatal (Dr. Daniel Dawson): No report

VIII. Open Forum –

Mr. Rice shared that his biggest concern going into the next 12-24 months is the American Rescue Plan Act (ARPA) funds. A white paper statement should be drawn up as a regional medical group stating what the group is facing and what we are up against.

Mr. Rice brought up the EMS dues of \$250 per provider. He suggested that the dues change to a fee/license instead to make the dues fairer for smaller agencies. Fee could be \$40 or \$50 per license, but the intent is not to increase the dues for the smaller agencies.

Mr. Richards shared that HCC meetings across the state have been cancelled. The hospitals have said they are too busy to take the time to meet. Board Members present want to continue the local HPP meetings.

GETAC is revising the RAC rules. They are in the draft phase and are trying to get it all together to put into the new Trauma Rules so they can be presented to the GETAC council together. Then it goes through a long legal process. The only thing that may relate to some in the room for uncompensated trauma, it will have to pass through facility trauma criteria and NTDB criteria to be eligible for reimbursement.

Mr Richards shared that the state will look at the staffing month-by-month and September 30th the staffing will not be removed.
