- I. Call to Order The meeting was called to order at 9:00 A.M. by Chairman Rice.
- **II. Introductions** All members introduced themselves.
- III. Approval of March 12, 2021 Meeting Minutes Mr. Matthews motioned to approve the March 12, 2021 meeting minutes. Ms. Parks seconded; motion carried.
- **IV. Financial Report** Mr. Sheridan directed the board's attention to pages 6 18 of the packet to review the financial report. The report shows that there have been no significant changes in the budget categories since the last meeting. The sleds requested by the perinatal committee were purchased, received and issued to Baylor Scott & White and CHI College Station. This expense closed out the perinatal allocation and utilized injury prevention funds.

There are several EMS County requests in process for EMS County II funds. Requests must be submitted by June 1st for reimbursement.

Mr. Matthews motioned to approve the financial report as presented. Ms. Kopech seconded; motion carried.

V. Executive Directors Report

- **A.** EMS County Update Update shared in the financial report.
- **B.** Healthcare Coalition Project Update Mr. Richardson reminded the group present that the vents were initially denied but the state did finally approve the project after addition information was provided. The vents are being ordered. They will be delivered to CATRAC and then issued out. There is just under \$10,000 remaining in that fund. There is also \$8,500 available in the HPP Budget. Both funds have to be spent by June 30th.

Ms. Kopech asked about purchasing Lucas Devices. Members present said that they are about \$10,000 each. Mr. Sheridan asked if there is any additional need for rescue pumps. Mr. Rice asked if any data on the use of the rescue pumps had been put together. Ms. Parks and other hospital representatives said that it was difficult to get staff to keep the data and did not have part that made the big difference.

One project discussed is a base station for Baylor Scott & White College Station. The cost is approximately \$3,000. The recommendation is that project comes out of the HPP funds. A second project discussed was a service contract with Texas Communications to check radio and equipment to make sure it is up to date and functioning. Mr. Rice shared that he could always use radios to help with supporting COVID clinics. Mr. Sheridan said that there are radios in the cache. Another project discussed is purchasing handheld glidescopes. The McGrath Laryngoscopes are about \$2,500 each. Mr. Matthews made a recommendation to purchase a Base Station for Baylor Scott & White College Station, Texas Communication Radio Assessment and the remaining funds to be spent on McGrath devices for the ERs.

- **C. Perinatal Project Update** The sleds were purchased and issued out. The project is complete.
- **D.** Trauma Service Plan Trauma Service Plan is outdated. This falls under the duties of the Board Secretary and the recommendation is to form a workgroup to review and work on the plan. The plan is current but has not been evaluated and modified in five years. Ms. Parks recommended that the stroke portion be a separate document. Mr. Sheridan asked Ms. Parks to work with Ms. Brooks in setting up a workgroup to review the plan.
- E. Essential Criteria The Department of State Health Services has essential criteria that all RACs must meet. The review of this is done when the annual report is submitted. Mr. Sheridan directed the Board members' attention to page 9 of the document. BVRAC is meeting all of the deliverables. There are some action items on here that we need to complete and there are areas where the RAC could improve. Please review the document and see if there are items that should be added to our objectives.
