- **II. Introductions:** General Assembly conducted self-introductions.
- **III. Approval of February 7, 2019 Minutes:** Mr. McKee motioned to approve the February 7, 2019 minutes. Mr. Matthews seconded; motion carried.
- IV. **Financial Report:** Ms. Parks provided the financial report as summarized on page 8-23 of the BVRAC General Assembly packet. The only transactions that have transpired include insurance payments, travel expenses for a GETAC meeting, stop the bleed kits and the radios. Ms. Parks encouraged everyone to be thinking about what to include in the budget for the next year, especially for LPG. The Board will be discussing the budget for the next year during the May meeting.

Ms. Johse motioned to approve the financial report. Mr. McKee seconded: motion carried.

## V. Chair Report

- A. EMS County Reimbursements: Mr. Rice directed the committees' attention to page 24 of the packet to review the distribution plan. The agencies that have used their allocation include Bryan Fire, Jewett, Robertson County, TAMU and Washington County. Requests need to be submitted by the end of July for processing.
- B. **Trauma Systems Plan Update:** Ms. LaPaglia encouraged all members to review the Trauma Systems Plan available on the BVRAC website. Suggestions for changes or updates should be emailed to Brandy at <a href="mailto:blapaglia@st-joseph.org">blapaglia@st-joseph.org</a> by end of July.

## VI. Committee Reports

A. **Disaster/Emergency Preparedness Committee (Cory Matthews):** The region will be without a full time dedicated Emergency Preparedness Planner with the resigning of Mr. Clouse. CATRAC is working to fill the position and will provide support until the position is filled. The only other update from the emergency preparedness committee is that there will be a surge test in Scott & White – Brenham and CHI Burleson in May.

Supply chain and integrity assessment survey was completed by 5 hospitals and one EMS agency. If you did not complete the survey, please complete it. The survey assesses what vendors everyone uses and provides valuable information for planning for emergencies.

Mr. Rice shared that the perinatal committee had a lot of discussion on evacuating NICUs during their meeting and believes that there is a lot of opportunity for the two committees to work together on the issue.

- B. Education (Ashley Kopech): The symposium for next year will be a two day event that includes stroke, chest pain, disaster management, perinatal, pre-hospital and other areas to include all areas and bring more attention to the RAC. There are many specialists here in our region that could do presentations to save money on paying presenters to come and speak. Anyone with ideas or input is welcome to help with planning. The committee would like to pay someone to take care of the CE/CMEs so the focus can be on other areas and attendees do not have to stay all day to earn credits.
- C. Pre-Hospital (Kevin Deramus): No report
- D. Hospital Care and Management/ Acute Care (Erin Gaas): Burleson CHI St. Joseph recently had the trauma survey in February. One area that was brought up was to use the trauma flow sheet on any traumatic patient. Ms. LaPaglia said a sheet was developed when she was there that collected key elements that are needed for each trauma patient. Another area that was reviewed was the broselow bags to make sure that your tape is the most current 2017 version. The surveyor also reviewed the process to draw at the outlying hospitals and at regional. The question came up to just do one draw to reduce duplicate work. Ms. Kopech added that they recently had a survey completed and their surveyor asked questions about emergency and disaster preparedness in addition to the regular questions. Mr. Sheridan was present and answered her questions.
- E. **Stroke** (**Rebecca Hickman**): Symposium is coming up on May 16<sup>th</sup>. Speakers will be covering stroke in the morning and cardiovascular issues in the afternoon. Cardiovascular and stroke coordinators have been meeting monthly and they have discussed making it an acute care meeting to involve other coordinators in discussions and planning.

Stroke Care for the region is going well. The region was at 9% last year on TPA and it is now at 13%. Those patients are getting identified better. The systems QI forms are not being submitted for those stroke patients that are being transferred out.

Mr. Rice commented that the regional stroke transport criteria needs to be updated. Ms. LaPaglia mentioned that during the strategic planning process they

had discussed setting up quarterly meetings for a physician's advisory group where issues like this could be discussed. May need a few workgroups before it goes to the physician's advisory group.

- F. **System QI/Physician's Advisory (Dr. Ohaju):** Dr. Jordan with Baylor Scott & White presented a case study for discussion that concerned an infant that fell onto the floor. The group present discussed the case and processes used. Procedures and communication were key areas that were identified for improvement.
- G. **Injury Prevention** (**Ashley Johse**): Received 85 new stop the bleed kits today and would like a new leg if any committees have money remaining. Will be teaching a stop the bleed course at Texas A&M and Dr. Van wants to do a stop the bleed program for the nursing students on May 17<sup>th</sup>. Will be getting a teaching set up at Allen Academy and International Leadership of Texas soon.

Ms. Kopech shared that the ACN asked if we would do a stop the bleed training on May 22<sup>nd</sup> at CHI St. Joseph and 23<sup>rd</sup> at Scott and White College Station. Courses will be held at 5:00 and 7:30 pm both days.

Ms. LaPaglia asked everyone to remember to put the stop the bleed courses on the facebook page to advertise them. Feel free to send it to Ms. LaPaglia if you want her to do it.

H. Perinatal (Ms. Phelps for Dr. Dawson): The committee discussed data points and how to improve quality metrics on breast milk, temperature, and other metrics. Also discussed disaster preparedness and how to evacuate patients and the best way to send patient records with the patients during a disaster and use of isolettes for some patients but not all. Members will reach out to facilities that are on the coast that have hurricane evacuation plans to see their plan for evacuating.

Mr. Rice said that Mr. Reimer would love to plan a disaster drill on moving babies. It is definitely a weakness and would bring panic to mind for many EMS agencies. Mr. Reimer agreed that it is a big issue in their region as well and with the maternal and neonatal designations coming on board there are many questions on how to deal with these patients during disasters.
