- I. Call to Order The meeting was called to order at 9:03 A.M. by Mr. Rice
- **II. Introductions** All members introduced themselves.
- III. Approval of July 12, 2019 Meeting Minutes Dr. Dawson motioned to approve the July 12, 2019 meeting minutes. Ms. LaPaglia seconded; motion carried.
- **IV. Financial Report** Mr. Sheridan directed the board's attention to pages 7 25 of the packet to review the financial report. Expenditures have remained the same from the previous month. There are several final pending expenditures that have do not show up on the report which include rescue pumps, stop the bleed training kits and instruction booklets as well as the Newborn Annie. There is \$6,137.07 available for stop the bleed kits as well as \$3,500 that was set aside in EMS RAC for stop the bleed kits.

Three thousand dollars was set aside for three people to attend the Pinnacle Conference. Only one person attended the conference. The board will discuss how to use these funds as an action item later in the meeting.

Everything has been paid for in EMS County and when the final check gets cashed, the balance will be zero.

Mr. Matthews motioned to approve the financial report as presented. Ms. Gaas seconded; motion carried.

V. Executive Directors Report

A. Contractual Changes – Mr. Sheridan shared that the current contract has July 31st as the final date for EMS County expenses. The new contract moves EMS County and all other contract deadliness to the right to start on September 1st and end on August 31st. This will align with the BVCOG fiscal year.

VI. Discussion/Action Items

A. Consider for approval reallocating remaining EMS Pinnacle Conference funding – Mr. Deramus is the only one that attended the EMS Pinnacle Conference in Florida. The group had previously allocated \$1,000 to each person that attended the conference. This leaves \$2,400 in the budget. The two options with these funds are to fund all eligible expenses for the one person who attended the conference which would use up most of the remaining money or take the remaining money and allocate it to stop the bleed. Mr. Matthews made a motion to pay all eligible expenses from the Pinnacle conference and use any remaining funds to purchase stop the bleed kits. Ms. LaPaglia seconded; motion carried.

VII. Open Forum

- A. Mr. Rice asked if the two people who won the SIM completion should book their hotel rooms for the EMS Conference directly or if the COG would book the rooms. Mr. Sheridan pointed out that the state had not released the RAC administrative funds yet so the RAC cannot spend the money and it is much easier to reimburse expenses. The two paramedics work for College Station Fire Department (CSFD) and Ms. Lugar is verifying that CSFD will book the rooms.
- **B.** Mr. Rice shared that the new helicopter will be here at the end of August. Pilots completed their training recently and some early in the year so they will all have to get current. The crew will be doing training runs for a week including fake runs for patients day and night. Everyone is welcome to ride along once it is in the rotation. The goal is to start IFR transition after it has been in rotation for 6 months.
