- I. Call to Order The meeting was called to order at 10:10 A.M. by Ms. Parks
- **II. Introductions** All members introduced themselves.
- III. Approval of November 8, 2019 Meeting Minutes Mr. Ruemke motioned to approve the December 5, 2019 meeting minutes. Mr. Deramus seconded; motion carried.
- **IV. Financial Report** Mr. Sheridan directed the board's attention to pages 6 10 of the packet to review the financial report. The FY2020 financial report shows expenses for salary and taxes. There was a small change in cost for management and report submission. Otherwise no major changes had developed.

Dr. Ohaju motioned to approve the financial report as presented. Mr. Deramus seconded; motion carried.

V. Executive Directors Report

- **A. SB 500 Contract Statement of Work** Mr. Sheridan reminded the board of the types of projects, and of the BOD decision to go with the "Wristband" projects. There were not many details regarding the requirements, but the State will send out Deliverables at a later date. Mr. Deramus and Ms. Kopech agreed to spearhead the efforts. Some clarity is needed in order to move on with such efforts.
- **B. Dues and Registration Tracker-** Mr. Sheridan stated that there had been many stakeholders that had not submitted their forms after various reminders and that EMS Funds would be reallocated to those that completed all requirements. Mr. Ohaju pleaded that there be oral attempts to communicate with stakeholders before reallocation decisions be made. Mr. Sheridan agreed to present a solution before General Assembly.
- **C. Attestation Update (Video)** Mr. Sheridan reminded all members of the required attestation video, and suggested that those who had not watched the video remain for a few minutes after the meeting in order to fulfill the requirement. The BOD agreed to the recommendation.
- **D. EMS County Update** EMS County funding expenditures have been shifted until the end of June. Participants must complete all requirements in order to be eligible for the funding
- **E.** Cyber Security Bernie Acre has taken the lead to form a cyber security work group. This work group is open to anyone who wishes to participate, and is tasked with mitigating the negative impacts of cyber-attacks. Mr. Sheridan asked the BOD if any of them would be interested, and received positive responses.
- **F. Disaster Day** Feb 22/23 the EMTF7 will come down to participate in a major exercise in conjunction with TTF1 and other groups. Mr. Sheridan will spread the information via email for this event for those that would like to participate.

VI. Discussion and/or Action Items

A. Consider for approval budget allocation for the SB500 new contract for \$27,184 – Mr. Sheridan recommended that this item be tabled in order to obtain new information. Mr. Deramus made a motion to table, seconded by Mr. Ohaju.

- **A. Education (Ashley Kopech)** Ms. Kopech reminded everyone that CHI will bring a case to the GA in February. There is some money to bring a class to all the hospitals. Some discussion was exchanged between the attendants about some places to start looking for good classes. The class would be done by June/July.
- **B.** Pre-Hospital (Message from Kevin Deramus) Mr. Deramus stated that EMS sent out somebody to fix some radios, but was not sure if that was completed, he offered to send someone out to teach radio usage to any group that needed radio education.
- C. Hospital Care and Management / Acute Care There was a meeting scheduled for that day (1.10.2020) and arrangements were made for when people arrived.
- **D.** Stroke (Rebecca Hickman) Ms. Jackson stated that they are coordinating with Acute Care for a symposium to continue educating health professionals about posterior stroke due to the difficulties with such cases seen across many hospitals.
- E. System QI / Physicians Advisory (Dr. Vincent Ohaju / Wanda Dias) Ms. Dias discussed changing some filters and asked about the different indicators and reported not receiving any indicators from other stakeholders. Ms. Johse discussed bringing the situation to the RAC for final decisions.
- **F.** Injury Prevention (Ashley Johse) Stop The Bleed will have 2 big classes and help is needed to run these events. The numbers will be reported to Mr. Sheridan to keep track of the progress towards the goal.
- **G. Disaster / Emergency Preparedness (Corey Matthews)** 3 Radios for PHI have arrived, but they need some adjustments. There was also discussion about some surplus equipment contained by PSP personnel which is available for any who need it. Mr. Ohaju expressed his interest in the objects and agreed to examine it.
- H. Perinatal (Dr. Daniel Dawson) No report

Mr. Sheridan reminded everyone about the public health training available in the future, he will notify anyone who is interested.
