- **I.** Call to Order: The meeting was called to order at 1:00 P.M. by Ms. Parks. Ms. Parks is standing in as Chair of the meeting due to Chairman Rice not being able to attend.
- **II. Introductions:** General Assembly conducted self-introductions.

- III. Approval of June 3, 2021 Minutes: Members present reviewed the minutes from June 3<sup>rd</sup>. Ms. Hill pointed out that Physicians Center is marked as absent but did have a representative at the last meeting. Dr. Ohaju motioned to approve the June 3, 2021 minutes with the correction. Mr. Ferrell seconded; motion carried.
- **IV. Financial Report:** Ms. Spittler directed the member's attention to pages 8 − 21 of the packet to review the financial report. These financials carry through June 30<sup>th</sup>. There is \$16,563.02 remaining in the RAC Systems Development Fund and \$22,559.04 remaining in the EMS RAC Fund. The new EMS LPG fund also has \$11,282 remaining. Many purchase orders are currently in process for the approved purchases from the last meeting. The support documents show details for expenditures and pages 20 − 21 show the payments made and funds received for each fund.

Mr. Matthews motioned to approve the financial report as presented. Ms. Johse seconded; motion carried.

V. Presentation – Tabletop Review of Mass Shooting at Kent Moore Cabinets by CHI St. Joseph Regional – Ms. Christian with CHI St. Joseph Regional reviewed a timeline of events from the mass shooting at Kent Moore Cabinets on April 8<sup>th</sup>. She also discussed the planning and actual events that have occurred in the county that helped with the response to this event. There were several things that went very well and several learning opportunities for the hospital and region. Some lessons learned included having phone numbers for critical contacts at each facility and agency, doing debriefing with all staff and knowing what resources are available.

#### VI. Executive Directors Report

- A. Update on Purchases Mr. Kazmir displayed a spreadsheet showing the current status on approved purchases to close out the contract. All purchases have either been finalized or have purchase orders in process. Ms. Kopech asked to add student handbooks for the ACLS and BLS courses.
- **B.** EMS County The state has not sent the distribution plan for EMS County.

**D.** Consider for approval the BVRAC Trauma Systems Plan - Ms. Brooks reviewed the changes made to the BVRAC Trauma Systems Plan including removing the stroke section and updating contact information. Mr. Matthews made a motion to approve the BVRAC Trauma Systems Plan. Ms. Johse seconded; motion carried.

### **VIII.** Committee Reports

- **A. Disaster/Emergency Preparedness (Cory Matthews):** Announcements from the HPP Meeting include:
  - 1. CATRAC is going through several staff changes with Mr. Douglas Havron becoming the new CATRAC Director and Ms. Joy Meehan announcing that she is leaving.
  - 2. EMTF 7 has been involved in over 40 deployments since COVID started.

There are boxes of wristbands in the back of the room and each EMS Agency should sign out a box. Training has not been done on the wristbands and hospitals are not set up as well but it will take some time to get personnel used to putting on the wristbands.

- **B. Education** (**Ashley Kopech**): BLS and Stop the Bleed Course will be held on September 24<sup>th</sup> at the COG. Information should be shared on the website to promote the course. This first course will help work out any kinks or issues in the process as the group gets set to host and provide more ACLS, BLS and Stop the Bleed Courses.
- C. Pre-Hospital (Kevin Deramus): No report
- **D.** Hospital Care and Management/ Acute Care (Debbie Burkhardt): The Hospital Group is continuing planning for the symposium and reviewing the materials from the previous years.
- **E. Stroke (Patti Parks for Paula Terrell):** The stroke section was pulled out of the BVRAC Trauma Plan and is being built as a separate plan. Draft documents will be sent out to for review.
- **F.** System QI/Physician's Advisory (Dr. Ohaju/Wanda Diaz): The regional transfer information has been updated. The region averages about 15 transfers per month and 60% are pediatric and burn patients.

Dr. Ohaju provided a case study to the group that went through the chronological events of a trauma case. One of the main opportunities for improvement identified is the team working as a unit starting at the scene and going through to the facility.

- **G. Injury Prevention** (**Ashley Johse**): Stop the Bleed training was provided to staff at Encompass Health and TAMU Mail Employees. There is training scheduled in Navasota ISD on August 10<sup>th</sup> and Leon County on August 11<sup>th</sup>.
- **H. Perinatal (Patti Parks for Dr. Dawson):** The facilities presented data collected and discussed maternity and neonatal designations that are coming up. The group is dealing with COVID and visitation and most are having just one visitor with the patient.

### IX. Open Forum -

Mr. O'Neal with the Brazos County LEPC shared that the LEPC meets on the third Thursday of each month at noon at the C&Js in Bryan (At the bend on Texas Avenue). The group would love to have representatives from the medical community join them. Honeywell will have a tabletop on September 9<sup>th</sup> and deal with chemicals that would be of interest to the medical community. They will be doing a hotwash at the October LEPC meeting if anyone is interested.

Mr. Kazmir shared that BVCOG will be hosting COVID Vaccine clinic on August 20<sup>th</sup> from 1-4 pm and everyone is welcome to come get a vaccine.

Ms. Parks reminded the group that RAC dues are coming up soon so those facilities that take a while to pay may want to get started.
