- I. Call to Order The meeting was called to order at 9:01 A.M. by Chairperson Rice.
- **II. Introductions** All members introduced themselves.
- III. Approval of September 8, 2023 Meeting Minutes Members present reviewed the minutes. Mr. Ruemke motioned to approve the September 8, 2023 meeting minutes. Mr. Giles seconded; motion carried.
- IV. Financial Report Mr. Baldree reminded the Board Members that the fiscal year turned over last month and the only major purchase is the Active Shooter courses through Threat Suppression. There is a little bit of overcharge in Admin at the moment, but it will be changed to reflect the full expenditure of the funds. There are no funds to carryover from last year.

BVRAC received a contract for the \$150,000 of extra funds that all RACs received. These funds were put into the EMS/RAC category with an important note that the funds are not going to be eligible to carryover to next year. Otherwise, there are no restrictions on these funds. These funds must be spent by August 31, 2024. So, they will be the first funds spent.

There will be a reflection of the revenue from the Symposium in the Unrestricted budget at the next meeting.

Needs assessments need to be submitted. Assessments have been received from Robertson County EMS, TAMU EMS, Bryan ISD and College Station Fire Department. Need to have an in-depth discussion on the budget and needs assessments at the Board Meeting in November.

Mr. Gallagher made a motion to accept the financial report as presented. Mr. Giles seconded; motion carried.

V. Executive Directors Report

A. Senate Bill 8 – The state sent out letters that ended the incentive program. The \$30,000 in the budget for incentives can be moved over to the Senate Bill 8 Distribution Pool. This is helpful since a couple of agencies are right at their allocated amount now. The new allocation amounts with the \$30,000 added are:

- conference. The date can be moved later in September. Need to work with the Brazos Center on their open dates.
- C. Memorandums of Understanding A local facility asked about Memorandums of Understanding between facilities in the region with the most recent one being in 2008. This may be something for a stroke survey but is not something that is normally part of the criteria. This was tabled for the time being.
- **D.** Website Mr. Baldree presented the new and updated BVRAC website to the Board. Mr. Baldree has instructions for updating the content of the website and will be adding calendar items and other updates as available.
- E. <u>BVWACS Radio Invoices</u> Ms. Mendoza with Baylor Scott and White College Station asked for clarification on the number of radios that BSW is charged for. She is only aware of two radios and the invoice is for four. A survey can be sent out to local partners to make sure radios are accounted for. Mr. Baldree asked Ms. Mendoza to reach out to Ms. Kopech about the radios since the same number has been billed for many years.

VI. Discussion and/or Action Items

- **A.** Consider for approval EMS County Distribution Plan The distribution plan was displayed for review. The funds are distributed by county and divided evenly among agencies that work in those counties. Mr. Gallagher asked about CHI AirMed 12 being added to the distribution chart and Chairman Rice said that they are included under the CHI EMS allocation. Ms. Parks made a motion to approve the EMS County Distribution Plan. Mr. Giles seconded; motion carried with one opposed (Mr. Gallagher).
- **B.** Discussion of Needs Assessment Submissions Submission of needs assessments will be emphasized at the General Assembly. The hard date to get the assessments submitted is November 1st.
- C. Consider for approval the BVRAC Trauma Systems Plan Ms. Parks noted that the dues for hospitals needs to be updated in the plan and the trauma and stroke designations need to be reviewed. Ms. Mendoza made a motion to approve the BVRAC Trauma Systems Plan with the changes noted. Mr. Giles seconded; motion carried.
- **D.** Consider for approval the Regional Stroke Systems Plan Ms. Plotts pointed out that there are a few grammar errors that need to be fixed in the plan. Ms. Plotts made a motion to approve the Regional Stroke Systems Plan with the changes. Ms. Parks seconded the motion; motion carried.
- **E. Discussion of Pulsara** The Renaissance Festival will be set up each day as a new incident in Pulsara.
- **VII. Committee Significant Items** There is a QI Form for VAN Data Collection that will be distributed at the General Assembly Meeting.

- **I.** Call to Order The meeting was called to order at 10:36 A.M. by Vice Chairperson Giles.
- **II. Introductions** Introductions were not done during this meeting.

III. Discussion and/or Action Items

A. Consider for approval BVRAC Regional Diversion Policy – Dr. Stewart made a motion to approve the BVRAC Regional Diversion Policy. Mr. Gallagher seconded. Discussion on the motion was opened. Dr. Stewart proposed an amendment to the top of page two where it says "Diversion due to capacity will not be granted" to add an additional qualifier to say that "Diversion due to capacity shall not be granted to any individual facility staffing less than 100% of their licensed hospital beds during the time the diversion is requested". Agency representatives discussed current situations with

staffed and licensed beds at local facilities. Several representatives stated that they are going on divert when they absolutely need to.

The NEDOCS score was discussed and a score of 180 may not be helpful or relevant since Baylor Scott & White College Station is rarely below 180. Ms. York suggested looking at the spread/difference between the NEDOCS scores instead of a defined score. The NEDOCS score in EMResource goes above 200 and using their NEDOCS score would make the score standardized across different agencies. The suggestion is to pick a spread of 50 and in a few months meet to reassess and possibly amend the policy. The NEDOCS score is built from licensed beds minus peds and OB. Discussion continued around staffed beds and licensed beds between different facilities. The end result is the area's hospitals respecting each other's status. A question was asked regarding state requirements on hospitals staffing versus the advertised licensed beds at the facility. There is no state requirement in that regard.

Mr. Baldree recommended that the group not approve the motion on the table and someone offer a new motion so that everyone is clear on the changes. Vice Chair Giles asked for a vote on the motion on the table. Motion failed with one yes vote.

Mr. Leland made a motion accept the Systems Coordination and Patient Flow document set to expire December 6th with the noted changes to the second page to include (1) Changing the wording on the top of page 2 to state Diversion due to capacity will not be granted if 2 facilities (St. Joseph Regional, St. Joseph College Station and Baylor Scott and White College Station) indicate the NEDOCS score gap is less than 50 and (2) Utilizing the EMResource NEDOCS score as the standard for the region. Dr. Stewart seconded; motion carried with one vote of no.
