- **I.** Call to Order: The meeting was called to order at 1:02 P.M. by Chairman Rice.
- **II. Introductions:** General Assembly conducted self-introductions.
- III. Approval of December 7, 2023 Minutes: Members present reviewed the minutes from December 7, 2023. Mr. Gallagher motioned to approve the December 7, 2023 minutes. Mr. Turek seconded; motion carried.
- **IV. Financial Report:** There have been no significant updates in the BVRAC contract financials outside of management expenses. Mr. Baldree placed many orders before his departure and the next financial update will reflect these purchases with Amendment 1 funds and other budget areas.
 - Mr. Ruemke made a motion to accept the financials as presented. Ms. Condrey seconded; motion carried.
- V. Presentation Update on Pediatric Readiness Dr. Kristen Christian Current statistics on pediatric emergency room visits and response were shared as well as the rules affecting local facilities. The Way Forward Fund (Toyota's Philanthropic Arm) is providing funds for this program. Further information and steps are anticipated in the coming months to provide information and training to EMS Agencies. Dr. Christian covered the next steps towards Peds Readiness for BVRAC which include:
 - **A.** Facilities should identify at least one and preferably more than one person in their facility to be coordinators. Should be identified by February 14th.
 - **B.** Train the trainer dates will be set up in April.
 - **C.** Facilities must complete the national pediatric readiness assessment and develop a plan to address the gaps identified by the assessment.

There are some pediatric readiness training courses available. The information will be sent out to the group for dissemination to all who are interested. The slides will also be shared with the general assembly. One infant and one juvenile mannequin will be available for use by facilities in the region and can be signed out like the stop the bleed trainers.

- VI. Executive Directors Report Mr. Graham has taken over the RAC duties and Mr. Heritage will be taking care of the rest of Mr. Baldree's former duties.

- C. Discussion and possible action regarding overpayment of students with Senate Bill 8 funds This item is tabled for the next meeting. A clerical error occurred, and a plan is being worked on and will be brought before the group at the next meeting.
- **D.** Discussion and possible action regarding "free for all" date for Senate Bill 8 funds The final date is April 1st. If an agency has funds allocated those funds need to be requested by April 1st or they will be available to any agency in the region on a first come first served basis. These funds must be expended by December 31st. If someone is already in school, then they are safe for the other semester payments.
- E. Discussion and possible action regarding length of BVRAC 2024 Symposium The symposium will be one day in September. More information will be shared as it becomes available.

VIII. Committee Reports

- A. Disaster/Emergency Preparedness (Bryan Ruemke/Herman Iles): There were 26 participants at the chemical spill tabletop on January 19th. There was a great turnout from hospitals, emergency management, public health, and fire. The group was able to review the regional plans as well as some agency plans and had some good discussions on how and when to notify other agencies and groups. Mr. Iles will be developing a document on how to request EMTF resources that will be given to emergency management and hospitals.
- **B.** Education (Adam Gallagher): AirMed 12 symposium is May 12th. Registration details and other information will be sent out soon. Ms. Parks will send out a survey to see what topics everyone is interested in for the BVRAC Symposium. The popular sessions last year were the case reviews. The RAC in Temple did two 30-minute talks on each topic for their symposium that seemed to work well. There should be 7 Nursing CEs available to those who attend the full day and Baylor Scott and White will be taking care of the CEs this time. Ms. Kendrick offered to help with setting up the speakers and mentioned that another conference does speed rounds that are 10 minutes per speaker.
- C. Pre-Hospital (Adam Gallagher for Kevin Deramus): Stroke data collection was a major discussion at the last meeting. Everyone agreed to modify their reports to help Ms. Plotts gather the stroke data. Ms. Parks asked if everyone has been able to turn on their VAN score documentation in ESO (Asked for Ms. Plotts). Everyone present has been able to turn on their documentation.
- **D.** Hospital Care and Management/ Acute Care (Lori Porter): No Report. The proposed Trauma Rules are up for comment until February 19th.
- E. Stroke (Patti Parks for Amy Plotts): Discussed in other areas.
- F. System OI/Physician's Advisory (Wanda Dias): Need a solution here.
- G. Injury Prevention (Brandi Mendoza): No Report
- H. Perinatal (Dr. Brading): No Report

Ms. Parks asked about collecting and reporting on total ISS Scores in facilities. They could blind them and it would help determine how injured patients are. This could be a new report to see what is going on with facilities in the RAC and the RAC as a whole. If you look at the stroke and cardiac CDC data, the mortality data is huge in some parts of the region. Ms. Dias said the data could be put with the % mortality to see who is dying.

Transfer reports have been done for years and we know who we are transferring out. This type of report could help our IP program and could build some actions and programs out of the RAC.

Ms. Dias showed the transfer outs for the region. There were 256 transfers out of the region through November. The other category seems high for this year. May need to review the neurosurgical transfers to see if there is anything to discuss/review there.

OMFS is no longer on call at CHI. There are protocols with outpatient follow-up, but this may have changed. Ms. Kendrick shared that OMFS surgeries are not an immediate need since you are usually waiting for swelling to go down. Can transfer out if it is more immediate. Air Transport has not been advised to change their procedures on where to take patients.

IX. Open Forum – There has been a recommendation to change RAC meeting times. Information will be sent out with recommendations. The Perinatal Committee was urged to participate in person for the next meeting in April so this may change the idea for other meeting time changes.

RAC Self-Assessment will be on all agendas until it is completed. Other RACs are fighting about this assessment but our goal is to turn ours in first. Mr. Gallager will help coordinate this effort.

The goal is all EMS Transfers will go through Pulsara – the ERs are the last step in the process of making this happen. Should be live soon.
