- **I.** Call to Order: The meeting was called to order at 1:01 P.M. by Chairman Rice.
- **II. Introductions:** General Assembly conducted self-introductions.
- **III. Approval of April 6, 2023 Minutes:** Members present reviewed the minutes from April 6, 2023. Mr. Giles motioned to approve the April 6, 2023 minutes. Ms. Jebson seconded; motion carried.
- **IV. Financial Report:** Mr. Baldree directed the members' attention to page 7 of the General Assembly meeting packet to review the financial roll-up. A budget amendment was approved by the Board this morning but is not reflected in this report.

Bryan Fire and CHI St. Joseph should submit requests for EMS County funds as soon as possible to ensure funds are utilized.

Ms. Johse made a motion to approve the financial report as presented. Ms. Jebson seconded; motion carried.

V. Executive Directors Report –

<u>Self-Assessment</u> – The self-assessment is not due this year since the trauma rules have not been finalized yet. Information and ideas have been gathered from other RACs on how best to complete the assessment.

<u>Symposium</u> – There was a meeting at noon today. The ticket portal / link for Eventbrite will be sent out so individuals can register for the symposium. The vendors and sponsors have been able to use their Eventbrite link for payments which has helped speed things up this year.

Senate Bill 8 Update – A budget adjustment will be done in the future for the admin and incentive costs based on how well the students do on their tests. The incentives are paid to the schools for properly preparing the students to pass on their first attempt with the test. The amount of tuition funds used as of June 1st is \$142,453.91 for the region. Students with CHI St Joseph, Jewett EMS and Robertson County EMS have received tuition payments recently. The group will need to look at the limits/allocations for each agency in the next few meetings. Future expenses include a large EMT course that Bryan Fire is hosting.

- **A.** Consider for approval appointment of Amy Plotts to Stroke Chair Ms. Parks made a motion to approve the appointment of Amy Plotts to Stroke Chair. Dr. Ohaju seconded; motion carried.
- **B.** Consider for approval FY2023 Budget Adjustment Each year a budget is made at the beginning of the year and then it is adjusted in June to match the actual and proposed expenses. Mr. Capener made a motion to approve the FY2023 Budget Adjustment as presented. Mr. Turek seconded; motion carried.
- C. Consider for approval the attainment of website re-design services There are several regulatory reasons that the BVRAC website has to be updated. The recommended bid is with the group that manages the BVCOG website so minor adjustments can be made by staff in the future. The Board approved spending up to \$3,500 for the website redesign this morning. Ms. Jebson made a motion to approve the attainment of website re-design services for up to \$3,500. Mr. Turek seconded; motion carried.

Ms. Parks noted that there are a large number of burns in this time period may need to consider this in injury prevention groups. The highest numbers of transfers for that period are hands, pediatrics and burns. Dr. Ohaju also provided a case study for discussion and education purposes.
- **G. Injury Prevention (Stacey Jebson)**: Will participate in First Friday tomorrow with community education on fall prevention, stroke and chest pain education.
- **H. Perinatal (Dr. Brading):** No Report given during meeting. Note added in chat was that Baylor Scott & White recently completed their maternal designation process and CHI St. Joseph is due next year.


