- I. Call to Order The meeting was called to order at 9:00 A.M. by Chairperson Parks.
- **II. Introductions** All members introduced themselves.
- III. Approval of March 14, 2025 Meeting Minutes Members present reviewed the March 14, 2025 meeting minutes. Chairperson Parks noted an error in the minutes on page 3 of 14 under the Pediatric Committee bullet. The sentence is not complete. The end of the sentence should be "x-ray or specific CT scan to send to the receiving facility". Mr. Giles made a

motion to approve the March 14, 2025 minutes with the change noted. Ms. Johse seconded; motion carried.

IV. Financial Report – Mr. Heritage directed the board members' attention to page 8 of the packet for the financial report. There is 70% remaining in the RAC Systems Development budget. Ideally, the budgets would all be 40-45% expended at this point in the year. Most funds for this budget are allocated to committees. Chairs need to be looking at what projects they want to pursue with the funds. The budget sheet on page 9 shows 60% of the EMS RAC budget remaining. There are a few allocations that haven't been taken out yet that will drop this number to close to 50%, which puts it in line with where it should be.

Several reimbursements for Amendment 2 funds have been paid out to Robertson County EMS, TAMU EMS and College Station FD over the last couple of months. Remember that requests for reimbursement must be submitted by May 31<sup>st</sup>. This gives the board time to take the consolidated amount remaining across all allocations and decide how to spend the funds. These funds can be rolled over to next year. The preference is to spend all funds before the end of the contract year.

The only payments that came out of unrestricted are for the accounting firm that does the RAC taxes and insurance.

Mr. Giles made a motion to approve the financial report as presented. Ms. Johse seconded; motion carried.

V. **Executive Directors Report** – Mr. Heritage distributed a printed copy of the new BVRAC Annual Report to all board members. This report highlights the goals and accomplishments of the BVRAC over the last fiscal year. Leadership in each agency can see what they are getting for their dues. Please send pictures from any BVRAC events to Mr. Heritage and Ms. Hill for inclusion in next year's report. The intent is to not do a full rewrite each year but to add any new accomplishments and update pictures and backgrounds.

Chairperson Parks, Mr. Heritage and Ms. Mendoza met with Ms. Goodman out at the TEEX facilities regarding having the BVRAC Symposium at TEEX this year. The symposium is scheduled for October 10<sup>th</sup>. It is a brand-new building with all the audio/video equipment needed for the event. TEEX staff will provide a presentation at the symposium. Mr. Heritage will start getting quotes next month for some of the recurring expenses and needs for the symposium.

Please submit requests for Amendment 2 and EMS County reimbursements as soon as possible.

The RAC Self-Assessment was sent out to all Committee Chairs and Co-Chairs with the chart designating which committees are responsible for what section. Committees should

meet, go through the assigned sections, and assign a score. The scores should be sent to Mr. Heritage by May 2<sup>nd</sup> to allow time for the board to review the full assessment before the August 31<sup>st</sup> deadline. In most areas, BVRAC would score a 3, with the scale of 1-5. One of the reasons the Annual Report was created was to get the region to a score of 3 for one of the sections. The plan is to submit this assessment in July to allow time for any corrections/changes the state may request. The board questioned whether other RAC's assessments will be available publically. It is hard to compare the large RACs with many paid staff members to the smaller RACs. The assessments should be public information and even posted on the RAC websites.

The Hospital / Acute Care Committee changed to Trauma / Special Populations last month. The plan is to take nominations for the chair for this committee at the next meeting. The objectives and priorities need to be outlined for this committee before that can take place.

VI. State RAC Chair / ED Meeting Update – No updates or information now. Chairperson Parks will participate in a meeting next week.

### VII. Discussion and/or Action Items -

**A. Discussion of Pulsara** – Pulsara was used at Chilifest this weekend with 170 patients and 5 transports and ran flawlessly. It is hard to imagine running these large events without Pulsara. The hospitals were added to the event this time so they could see the patient counts in the community and where everyone was.

- b. Stroke A presentation will be provided during the General Assembly
  meeting this afternoon. Ms. Plotts asked about the invoice for the Stroke
  Awareness Campaign. Mr. Heritage shared that he had not received an invoice
  yet.
- c. Pre-Hospital There is a pre-hospital meeting scheduled next week.
- d. DEPC MERCI is April 23<sup>rd</sup>. There will be two presentations during the HPP meeting on dialysis in emergencies and Red Cross response. If anyone needs to add something to the MERCI exercise, please let Mr. Iles know.
- e. Injury Prevention A CarFit instructor course will be set up as well as a Stop the Bleed course to get more instructors signed up. If someone is interested in being a Stop the Bleed instructor they must meet certain certification requirements and fill out a form online as well as participating in the training. Ms. Fisher asked about the WHALE project. The plan is to get more information together on WHALE for the next Board meeting in May. Dr. Christian shared that they have a meeting this weekend so she will know more about it then. Chairperson Parks asked if there are any summertime injury prevention focus areas where the marketing group could be used. Ms. Fisher is

getting an injury prevention meeting set up and will bring it up in the discussion.

- f. Trauma / Special Populations Ms. Porter will continue looking at vendors for the symposium. Chairperson Parks has a couple of vendors (EIO and Primeway) that are interested in participating. Chairperson Parks asked if St. Joseph will be willing to do the CE's this year. Ms. Porter also said that vendors will want to see a draft agenda for the symposium to see how much time is allocated for participants to visit the vendors.
- g. Systems QI Presentation will be provided on burns today. Another case will be presented at the June meeting.

Ms. Goodman shared that TEEX will plan on setting up a mobile disaster kit during the symposium where participants can practice skills. Chairperson Parks asked if the group would be interested in having a hands-on area. May look at difficult airways, IO, or other skills. People would need to man these stations so volunteers are needed, which also means it would not be all day. Please share any skills to add for the hands-on part. Ms. Mendoza suggested needle decompression. Chairperson Parks suggested asking Ms. Kendrick to be chair over the skills section and help Ms. Goodman.
