- I. Call to Order: The meeting was called to order at 1:00 P.M. by Chairperson Parks.
- II. Introductions: General Assembly conducted self-introductions
- III. Approval of General Assembly's June 12, 2025 Meeting Minutes: Members present reviewed the minutes sent out in the packet and displayed at the meeting. Mr. Gallagher motioned to approve the minutes. Mr. Deramus seconded; motion carried.
- IV. There will not be an election for Secretary today. The bylaws were misread and the position is not up for election this year. Nominations for Treasurer will be accepted starting at the end of this meeting and members will vote at the next meeting. Today, members will vote on BVRAC Vice Chair. Three nominations were submitted. Ms. Christian and Mr. Gallagher both accepted their nominations. Mr. Rice declined the nomination. Members present voted online. Only one vote will be accepted from each member agency.
- V. Presentation: Katy Villereal-BSW and Stephanie Wilson-St. Joseph Hypertension in Pregnancy Definition, risk factors and risks for hypertension in pregnancy were covered as well as a case study.
- VI. Results of Voting Chairperson Parks announced that the votes were counted and Ms. Christian is the new BVRAC Vice Chair by a vote of 11 to 9.
- VII. Financial Report: Mr. Heritage directed the members' attention to page 8 of the packet for the start of the financial report. Updates include:
  - The Systems Development budget includes allocations to RAC Committees to go out and do education, outreach and training to benefit these different systems of care. There is 44% remaining in the RAC Systems Development budget. Funds have been allocated to expend all funds by the end of the contract on August 31st. The Perinatal Committee is doing an education and outreach collaboration with Impact Group. The Injury Prevention Committee is doing another Fall Prevention Campaign with KBTX. Wristbands have been ordered. An additional Stop the Bleed Training kit will be ordered to house here at BVCOG that will be available for training in the region.
  - EMS RAC funds are used for salaries and other operating expenses here at BVCOG to support BVRAC activities and deliverables. There is just over 36% remaining in the EMS RAC budget. There is an agenda item later in this meeting to rollover \$10,000 of these funds to next year which would allow the management allocation of \$10,000 in Amendment funds to be added to the EMS agencies and Hospital allocations next year. After moving the \$10,000, the \$4,000 remaining will be fully utilized by the contract end date.

- Amendment 2 covers allocation to eligible hospitals and EMS agencies. There is just over 50% showing as remaining in this budget but several agencies have reached out and have requests in process that will utilize their allocation. The additional \$10,000 in the Hilltop Lakes' allocation and \$1,379 in Jewett EMS' allocation were approved by the board at an earlier board meeting to utilize remaining funds. The anticipated final budget was displayed.
- EMS County funds are available to eligible EMS agencies in the region. All funds have been expended in the EMS County budget.
- There have not been any expenses taken out of the Unrestricted Budget. There is \$70,545.68 available in the unrestricted budget.

Ms. Heredia made a motion to accept the financial report. Mr. Gallagher seconded; motion carried.

VIII. Executive Director's Report – Mr. Heritage has been working with Chairperson Parks, Mr. Deramus and Mr. Gallagher on the Statewide Whole Blood Initiative. Mr. Gallagher was appointed to the state task force for this initiative and is meeting weekly to discuss how this program will be implemented. Surveys have been sent out to hospitals and EMS agencies by email. If anyone wants to participate, surveys must be completed and sent back by Thursday of next week. If a survey is not completed, that agency/facility will not be eligible to receive funding over the next two years. The state is determining how to distribute funding for this program. These patients will be tracked using the wristbands and facilities/agencies will be able to build reports from this.

Mr. Rice shared that everyone should be very proud of where we as a region are on wristband utilization and Pulsara. The region is ahead of many regions and even the state on many aspects of these programs by being proactive rather than reactive. Mr.. Rice and Mr. Miles met with the RAC in Tyler regarding Pulsara and wristband use in BVRAC.

#### IX. Discussion and/or Action Items

- A. Consider for approval and vote on nominations for BVRAC Vice Chair Members voted and results were announced earlier in the meeting.
- B. Consider for approval and vote on nominations for BVRAC Secretary Action item not needed. Nominations for BVRAC Treasurer will be accepted for vote at the next meeting.
- C. Consider for approval a budget amendment to the FY25 EMS RAC Budget Mr. Heritage directed members attention to the budget sheet on page 13 for the current and proposed EMS RAC budget. The current budget has \$39,773 in the Management line item. The proposed budget amendment is to rollover \$10,000 to next year's budget. This would change the management line item to \$29,773. These funds being available next year will increase the amount available to hospitals and EMS agencies through the Amendment/EI funds since there will be a reduction in the amount allocated to management expenses. Ms. Guerra made a motion to accept the budget amendment to the FY25 EMS RAC budget. Ms. Mendoza seconded; motion carried.

D. **Discussion of RAC Symposium** — The proposed agenda was displayed, and Chairperson Parks noted a few changes to the order in presenters. There will be skills stations available from 11:45 — 1:00 to include air way, maternal and pediatrics as well as some others. The symposium will finish at 3:00. The website is available and tickets can be purchased now. The price is \$15 and includes a lunch, t-shirt and swag bag. If you know of anyone that would be interested in donating items towards door prizes. Thank you to Jason who obtained a lot of door prizes, snacks and drinks for free for previous symposiums.

#### X. Committee Reports

- A. Disaster/Emergency Preparedness (Herman Iles / Bryan Ruemke):. Topics discussed at the meeting today include:
  - Presentation from Texas A&M Agrilife Extension There are a lot of resources available.
  - If you are reporting bed numbers into your own system, BedSync will link up and add to EM Resource. The state will be paying for it through 2028.
  - Monthly Communication Drill will be August 28<sup>th</sup> in the evening from 8:00 10:00 pm. It will be a Pulsara and EMResource Drill. The Six Month required drill will be on September 26<sup>th</sup> and will include Pulsara and EMResource.
  - HVA and Risk Assessment was sent out. Please send back asap.
  - MERCI exercise is in April 2026. Planning starts in September. If you are interested in participating, contact Mr. Iles.
- B. Education (Adam Gallagher): Mr. Gallagher shared that there was a call last week and you could tell which responders had taken NRP. The Perinatal Committee was approached about providing another NRP class.
- C. Pre-Hospital (Kevin Deramus): Few updates:
  - Quick reminder that the committee meets once a month outside of General Assembly. There are participation requirements for EMS Agencies.
  - Senate Bill 1377 got approved and is on the comptroller's desk. Mr. Rice asked if anyone understood it. The general understanding is that the money goes to the county and the only eligible purchase is an ambulance. There are some concerns in the region with this funding.
  - Senate Bill 8 funding will be available through the Workforce Education Department. The process will be a little different.
  - Pre-Hospital Readiness please make sure that you have completed this. There is a link on the website.
  - The whole blood task force is meeting weekly.
- D. **Trauma /Special Populations (Courtney Saunders):**. We are still collecting data for transfer times so hospitals please keep sending data. The new trauma rules start September 1<sup>st</sup>.
- E. Stroke / Cardiac (Chairperson Parks for Amy Plotts/Shelby Reed): No updates
- F. System QI/Physician's Advisory (Dr. Nicholas Nunnally / Amber Heredia): Ms. Heredia is collecting the data on the transfers that will be attached with Ms. Saunders' information. There are a few facilities that have not sent in their data. Please send any data that should be reviewed as a region. Chairperson Parks shared that Dr. Chance Sims is interested in participating with the committee.

- G. Injury Prevention (Riley Fisher/Christina Nickerson): Updates include:
  - It is stop the bleed season so there are lots of courses going on. The schools are getting teachers and students trained.
  - CartFit Training is on October 17<sup>th</sup>. Updates will be sent out later this month with registration information. A CarFit event will be held on October 18<sup>th</sup>.
- H. Perinatal (Chairperson Parks for Dr. Katie Brading): Mr. Gallagher suggested having the NRP class in the region. The NRP course is going through some changes and there is a new track for EMS. There will be new books as well. Mr. Gallagher mentioned that he noticed they use a lot of blood and asked members of the committee about using whole blood and they said yes. It may be good to have a representative from their committee on the regional whole blood group.
- XI. Open Forum Mr. Gallagher introduced Mika Isbell who is setting up Community Paramedicine in Robertson County EMS. She officially starts October 1<sup>st</sup> and will be working to make contacts across the region.

Ms. Guerra shared her appreciation to the board for receiving the extra funds. Their transport time is 45 minutes and the new equipment will help improve patient care.






