- I. **Call to Order:** The meeting was called to order at 1:00 P.M. by Chairperson Parks.
- II. **Introductions:** General Assembly conducted self-introductions
- III. **Approval of General Assembly’s August 7, 2025 Meeting Minutes:** Members present reviewed the minutes sent out in the packet and displayed at the meeting. Ms. Guerra motioned to approve the minutes. Ms. Johse seconded; motion carried.
- IV. **Financial Report:** Mr. Heritage directed the members’ attention to page 7 of the packet for the start of the financial report. The new contract started on September 1st, so the funding and budget have been reset. Updates include:
 - The only expenses so far for EMS RAC and RAC Systems Development are management expenses.
 - Disregard the dollar amounts next to each entity under the Amendment 3 budget. These amounts will not be determined until the needs assessments have been returned.
 - EMS County funds for the region decreased by about \$1,000 from last year. These funds are available to eligible EMS agencies as determined by the state and RAC participation.
 - There have been several expenses taken out of the Unrestricted Budget to include payment to the accountant for filing taxes, renewal of website hosting services, BVWACS radio invoice to Washington County. The BVWACS radio invoice is reimbursed by those entities that have radios in the program. There is a running line item for expenses for the BVRAC Symposium. There is \$62,813.11 available in the unrestricted budget. As members pay dues, the amount will go up by about \$9,200. There will be some funds added from the symposium as well.

Ms. Mendoza made a motion to accept the financial report as presented. Mr. Torres seconded; motion carried.
- V. **Executive Director’s Report** – On September 1, a new fiscal year started. Work is still being done to close the previous fiscal year and to submit some required end-of-the-year reports. The country is in a government shutdown. RAC contract funds are given in a

lump sum payment at the beginning of the contract year so the RAC should not see any effects from this. Other updates include:

- Wristbands are available for pick up after the meeting.
- Funds were allocated from last year's RAC Systems Development budget to purchase pediatric mannikins for all hospitals in the region except for one that opted to get some training clings for their existing mannikins. The mannikins and training clings are on the back tables ready for pick up.
- Request for membership dues and updated representation forms went out last month. These funds go into the unrestricted budget and are used to pay expenses that are unallowed in the contract to include taxes, insurance, website, sponsoring different associations, appreciation lunch in the December meeting and other expenses.

VI. Presentation: Kat Ruiz and Jasmine Castaneda de Morales with CATRAC provided an update on CATRAC's regional whole blood program. They have moved to an app for their whole blood administration form and process. They reviewed the experience for EMS, Hospital Outcomes and Hospital Blood Bank Notifications in their app and process.

VII. Chairperson Parks added the following updates to the Executive Directors Report from the RAC Chairs Meeting in September:

- The maternal rules will be going to a subcommittee for changes at the start of the year and the stroke rules are changing soon.
- The biological sex will be required by October 21st in reports. EMS agencies should check with their software to make sure this is being captured.
- Senate Bill 8 funds will be going through the Workforce Commission. Funding is expected to be lower.
- The RAC Self-Assessment for the next go round will include perinatal, maternal, trauma, stroke and other areas. Mr. Heritage and Ms. Hill will be sending out requests for input to the assessment.

VIII. Discussion and/or Action Items

A. Consider for approval and vote on nominations for BVRAC Treasurer – Ms. Brandi Mendoza and Mr. William Rice have been nominated to be BVRAC Treasurer. Both accepted the nomination. Members voted using the QR code provided. Mr. Heritage pointed out that each member agency is only allowed one vote so please talk to other people within your agency. Members present discussed reviewing the bylaws regarding heavy representation by one agency in BVRAC. Chairperson Parks proposed a subcommittee to work on this and bring it back to the membership. Those that are interested in participating should email Chairperson Parks.

B. Discussion of RAC Symposium – The CEs have been completed. A group will be going out to TEEX after the meeting today for a final walkthrough to see where things should be set up. There will be QR codes to register when you come in and for the evaluations. The symposium is expected to be a bigger and better event than previous symposiums. Please let us know if you want to help on the day of. Lunch will be at

11:30 and the skills stations will be set up to allow participants to go through them after lunch.

IX. Committee Reports

A. Disaster/Emergency Preparedness (Herman Iles / Bryan Ruemke): Topics discussed at the meeting today include:

- Presentation from EMTF with CATRAC. There are many teams they can send out if you need them.
- The October communications drill will be on the 7th to coordinate with DSHS' drill
- The MERCI exercise is on April 15th. If you are interested on being on the committee to help plan the exercise, please contact Mr. Iles.
- Mr. Iles asked members to send him any changes that should be made to EMResource to make it more useful/helpful.

B. Pre-Hospital (Kevin Deramus): The last committee meeting included several presentations on how EMS agencies are using Pulsara for events and day-to-day response. The State EMS Director was also present to go over the legislature updates for EMS agencies. Mr. Heritage will bring Workforce staff in to discuss Senate Bill 8 funding and process. There was also a discussion on the whole blood initiative and education requests.

C. Education (Adam Gallagher): The Board approved spending up to \$10,000 for the FTEP course. Dates will be selected and sent out to all EMS directors to get participants signed up. If you send participants to the FTEP course, there will be a deposit required to hold the seat. The deposit may be returned if the person shows up to the class. The reason for the deposit is to try to reduce the number of people who do not show up at the last minute. There are people on the waitlist that can't attend at the last minute, so the seats are empty.

May be using some education funds to purchase NRP books that include an update for EMS. The Perinatal Committee is putting together the hands-on portion for the NRP updates. The books can be shared among the EMS agency personnel that are working on their updates/training.

D. Trauma /Special Populations (Courtney Saunders): We started monitoring transfer times in June in anticipation of the new rules. After the release of the rules and some discussions with DSHS, the data will need some additional details. For transfers that occurred after September 17th, the spreadsheet will include requests for information on transfers over two hours for patients meeting emergent criteria, decision time to transfer, time of images initiated to dictation time, and reason for delay. The state is holding trauma program managers responsible for why patients are not getting transferred out of the hospitals. The hope is to identify areas that the RAC can help. This is the first area of focus that will also include stroke and perinatal patients at a later date.

- E. **Stroke / Cardiac (Chairperson Parks for Amy Plotts):** VAN data is still being collected so it can be presented.
- F. **System QI/Physician's Advisory (Dr. Nicholas Nunnally / Amber Heredia): Ms. Heredia went over transfer data for the region.** There were 139 total transfers with over half being pediatric or orthopedics patients. The top three receiving hospitals were Baylor Scott & White Temple, Memorial Hermann and Texas Children's. The arrival agency is now being collected as requested by the EMS agencies.
- G. **Injury Prevention (Riley Fisher/Christina Nickerson):** Updates include:
- There are two stop the bleed classes coming up on October 22nd and 29th. This is for the Corp of Cadets and there will be 500 participants. Teachers are needed for both classes. This is a repeat of what happened last year. All stop the bleed kits will also be needed on those dates. If you have staff you can send, it would be appreciated.
 - CarFit Technician Training is still open for all of the Brazos Valley. The training is on October 17th. A CarFit event will be held on October 18th at the Center for Regional Services.
- H. **Perinatal (Stephanie Wilson for Dr. Katie Brading):** The committee discussed the NRP course for EMS as well as the skills stations for the Symposium. The potential dates for the NRP course are January 21st and 28th. The cost will be \$45 when they sign up on the website. This is part of the required outreach for the perinatal program managers.
- X. **Open Forum –** Mr. Mendoza asked how EMS agencies would feel about hospitals providing some hoover mats for bariatric patients. It helps trauma nurses move these patients once the EMS personnel leave. Mr. Gallagher suggested they should be on supervisor vehicles.

Ms. Heredia asked that everyone check the patient information (name and date of birth) in Pulsara. There has been an increase in number of errors. Mr. Rice asked that he be notified when an error is found so he can reach out to that crew.

Chairperson Parks reminded everyone that armbands are now required. It needs to be on the patient and not off to the side or left on the counter.

Mr. Heritage shared that the state has given some requirements for EMS Agencies to participate in the Whole Blood Program. Those requirements include:

- Using wristbands
- Meeting RAC participation requirements - Agencies are required to attend a certain number of General Assembly meetings and committee meetings.

The RAC will also need to have a MOU on file with each of the EMS Agencies.

Ms. Heredia gave a shout out to St. Joseph EMS regarding a STEMI that was a 48-minute trip. The patient was almost stabilized at arrival and there was a 15-minute time from arrival to intervention. Also, a shout out to College Station Fire Department. There was

also a pediatric trauma patient with a very smooth response, and staff and family were very impressed with the collaboration as a unit. Chairperson Parks shared a shout out to Washington County EMS for a collaboration with a patient that was transferred to Temple by helicopter. The patient went into surgery quickly upon arrival and is home recuperating. Kudos were also shared for Bryan Fire and St. Joseph EMS Flight Crew.

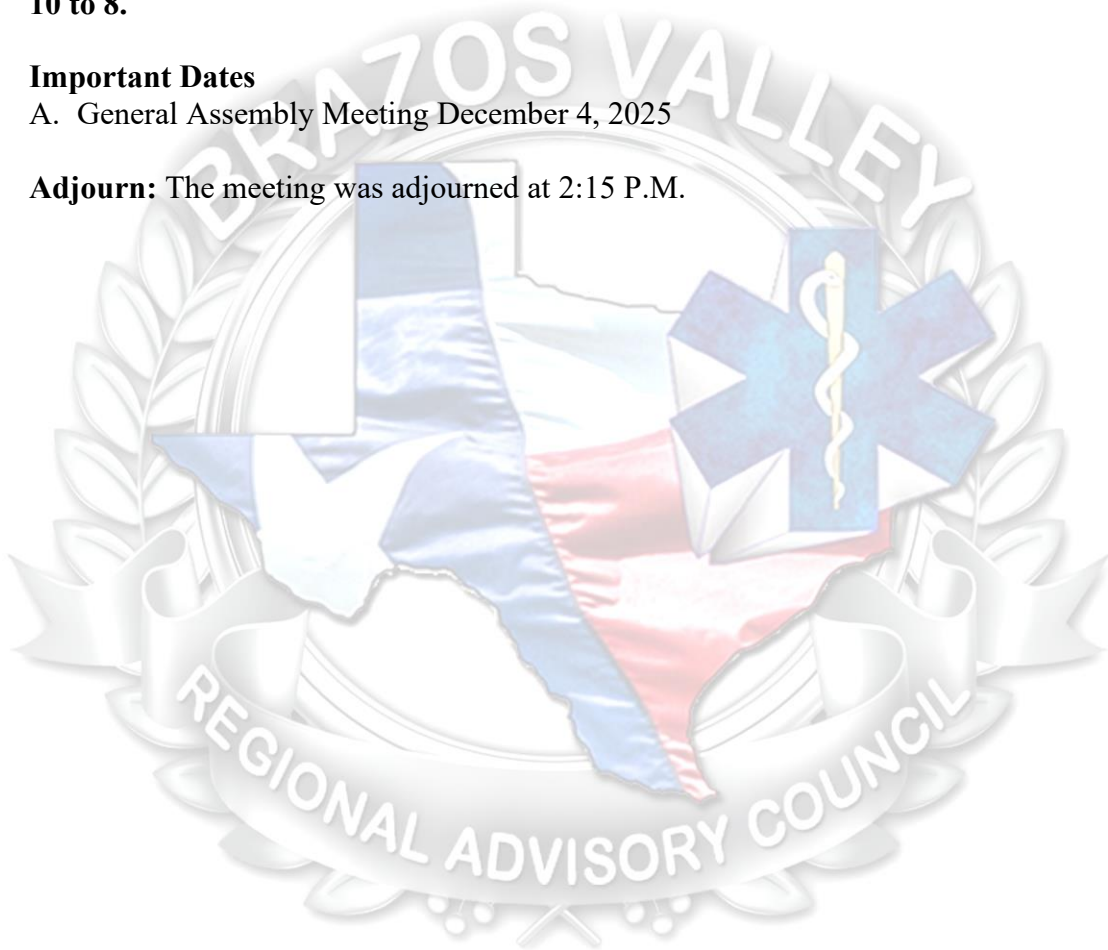
It was noted that the new trauma rules require administration of antibiotics within sixty minutes of arrival of EMS.
