- I. **Call to Order** – The meeting was called to order at 10:00 A.M. by Chairperson Parks.
- II. **Introductions** – All members introduced themselves.
- III. **Approval of December 4, 2025 Meeting Minutes** - Members present reviewed the December 4, 2025 meeting minutes. Ms. Johse made a motion to approve the December 4, 2025 minutes. Ms. Fisher seconded; motion carried.
- IV. **Financial Report** – Mr. Heritage directed the board member's attention to page 6 of the meeting packet for the financial report. Updates include:
  - EMS RAC has 81% remaining in the budget. Ideally, the total would be closer to 75%. There is an agenda item later in the meeting to utilize funds to replenish the wristband stockpile. This will get this budget closer to 75%.

- RAC Systems Development budget is at 77% remaining. Several travel reimbursements were made out of this budget for the TETAF and RAC Summit Meeting. The Stroke and Injury Prevention Committees are working with Impact Marketing group to develop two projects. The other half of FTEP will also be paid by the next meeting.
- The Amendment 3 budget was approved at the last General Assembly Meeting. Bryan Fire and Jewett EMS submitted requests for reimbursement with this fund. There is also a payment going out to College Station Fire.
- Two payments went out from the EMS County budget to Bryan Fire and Jewett EMS this month. Please gather any eligible expenses and send them in for reimbursement.
- The unrestricted budget has not had any new expenses. The current balance in the unrestricted budget is \$76,807.12.

Ms. Fisher made a motion to approve the financial report as presented. Ms. Johse seconded; motion carried.

**V. Executive Directors Report: - Updates include:**

- A. An email was sent out to all Trauma Program Managers in the region earlier this week. One of the discussion items at the TETAF meeting was delayed trauma transfers. TETAF put together a survey to rank the top 18 reasons for severe trauma patients with delays longer than two hours. The survey is due by January 31<sup>st</sup>. BVRAC will do it's own internal data collection as well.
- B. It is time to update plans. There is a google document for the Stroke Systems Plan and one will be created for the Trauma Systems Plan.
- C. Wristbands were discussed at the RAC Summit. The state pulls every run sheet to look at compliance with wristband usage. This includes moving someone back to the nursing home and other times when the wristband is usually not used. This is why BVRAC's numbers are so low.
- D. The next RAC Self-Assessment will include every committee.

**VI. Discussion and/or Action Items –**

- A. **Consider an appointment to the SETRAC Blood Products Committee Meeting –**  
BVRAC has opted to participate in SETRAC's Blood Products Committee. All participating EMS agencies are encouraged to attend as well as medical directors. BVRAC gets one voting member seat. There are two other RACs besides SETRAC and BVRAC that will have a voting member. Board members suggested that Mr. Gallagher be the voting member. Dr. Holcumb has offered to work with Mr. Gallagher as well. Ms. Fisher made a motion to accept Adam Gallagher as the voting member on the SETRAC Blood Products Committee. Dr. Christian seconded; motion carried.
- B. **Consider for approval an expenditure of approximately \$3,000 to purchase EMS wristbands –** Mr. Gallagher asked if the upgraded wristbands with the triage section

could be ordered in addition to the regular ones. The upgraded ones can be kept on the supervisor vehicles. Mr. Heritage will purchase some of the upgraded ones with the regular ones. Dr. Christian made a motion to approve the expenditure of \$3,000 to purchase EMS wristbands. Ms. Sanders seconded, motion carried.

- C. **Discussion of RAC Symposium** – Ms. Montgomery at TEEX sent some potential dates for the RAC Symposium. The group needs to find out when the calendars go out for the school districts. The options are a Wednesday, Thursday or Friday. The group agreed to stay away from Fridays. The hope is to get Save the Dates out early.
- D. **Discussion of Pulsara** – There are some false activations for STEMI patients. It is not necessarily activations in the field. If you have a patient with chest pain, what drop down are you using? General should be selected but there seem to be some selecting STEMI. This will be added to the Prehospital meeting as a reminder.

**VII. Committee Significant Items**

- A. **Disaster / Emergency Preparedness** (Herman Iles) – The MERCI drill is coming up in April. The next MERCI workgroup is January 23<sup>rd</sup>. Other regions are preparing for the World Cup as well. The next Communications Drill is January 29<sup>th</sup>. This will also be the six-month drill. This drill may be done at night. The nominations for Chair and Co-Chair are still active. There are no nominations yet. There are some proposed changes to EMResource coming up. There are different views for each of the regions and the end goal is for all the views to be the same.
- B. **Pre-Hospital** (Kevin Deramus) – A meeting will be scheduled soon. The House Bill 2000 applications went to the County Judge. The judge has to build the user account. Close date is 1/31/2026.
- C. **Trauma / Special Populations** (Erin Gass/Courtney Saunders) – Mrs. Hill will take the data and decode it and send the compiled data to Ms. Gass and Ms. Saunders to deal with the different software applications used. A meeting will be scheduled next week with the Trauma Program Managers. Chairperson Parks shared that the delay in transfers is going to be a big part of things moving forward and would like to do a case review.
- D. **Stroke / Cardiac** (Amy Plotts) – The committee is reviewing the BVRAC Stroke Plan. Please send in any suggestions. PediStroke needs to be addressed regarding where they are sent.
- E. **System QI / Physician's Advisory** (Dr. Nicholas Nunnally/Amber Heredia) –No updates.
- F. **Injury Prevention** (Riley Fisher/Christina Nickerson) – During the December meeting it was brought up that we should do something with pedestrian safety with a focus on scooter safety. The plan is to do a digital campaign with Impact Marketing in February. The Traffic Safety Coalition has also been contacted regarding doing something on campus as well. The total number of stop the bleed participants is 1,459 individuals.
- G. **Perinatal** (Dr. Brading) – The NRP class at the end of January. The books are being ordered. Mr. Gallagher noted the price increase.
